



## SETUP GUIDE FOR MINIORANGE AS IdP

### STEP 1: Creating App in miniOrange

- Go to miniOrange Admin console <https://auth.miniorange.com/moas> and login with your miniOrange credentials.
- From the left menu, go to **Apps > Manage Apps**.
- In the right upper corner, **select Configure Apps**.
- In the search apps textbox, type **Custom App**. Select **Custom App** and click on Add App.
- Enter the following the textboxes:

<b>Custom Application Name</b>	App name you like to provide. Eg: Drupal
<b>SP Entity ID or Issuer</b>	Enter <b>SP Entity ID / Issuer</b> from the Identity Provider tab of the module
<b>ACS URL</b>	Enter <b>ACS (AssertionConsumerService) URL</b> from the Identity Provider tab of the module
<b>Single Logout URL</b>	Enter <b>Single Logout URL</b> from the Identity Provider tab of the module

- Click on Save to add the App.
- From the Configured App list, click on the Download Certificate link in the Action against the Drupal application you just added.
- Open the downloaded certificate in Notepad and keep it handy. It will be required while configuring the SAML module (Step 3).

### STEP 2: Creating Policy for the App

- From the left menu, go to Policies > App Authentication Policy
- Click on App Policy tab.
- From the Application dropdown, select the Custom Application Name you provided before.



- Select DEFAULT from the Group Name dropdown.
- Enter Policy Name you would like to provide. Eg. Drupal Policy.
- Select Password from the First Factor Type dropdown.
- Select Password from the First Factor Type dropdown.
- Click on Save to save the policy.

In the miniOrange SAML module, go to Service Provider tab and configure miniOrange IdP as:

- **IdP EntityID:** <https://auth.miniorange.com/moas>
- **SAML Login URL:** <https://auth.miniorange.com/moas/idp/samlso>
- **SAML Logout URL:** <https://auth.miniorange.com/moas/idp/samllogout>
- **X.509 Certificate:** Copy/Paste the entire content of the certificate file opened in Notepad.
- **Response Signed:** Checked
- **Assertion Signed:** Unchecked
